Supervisor Lummus moved to authorize and approve to advertise notice to the public of the Board's intent to apply for funding to repair the cross ties on the rail spur located at the YTTM through the MS Development Authority Rail Loan Program.

AUTHORIZE AND APPROVE THE CLERK TO SUBMIT RAIL LOAN APPLICATION THROUGH THE MS DEVELOPMENT AUTHORITY IN THE AMOUNT OF \$400,000 FOR THE PURPOSES OF REPLACING CROSS TIES AT THE RAIL SPUR AS LOCATED AT YTTM FACILITY

Supervisor Lummus moved to authorize and approve the Clerk to submit Rail Loan Application through the MS Development Authority in the amount of \$400,000 for the purposes of replacing cross ties at the rail spur as located at YTTM Facility.
