Judge Storey has a long and distinguished career in public service, having served the State of Mississippi and Clay County with honor and integrity as a Youth Court Referee and Special Master for civil commitments after being appointed to that position on January 1, 1972.

Judge Storey's service has been instrumental with the development of Youth Court practices and procedures. Judge Storey, along with Supreme Court Justice Mike Randolph, were responsible for the Task Force of Youth Court Rules of Procedure being created by Order of the Mississippi Supreme Court. Judge Storey and Justice Randolph were tasked with overseeing the development of a set of uniform rules of procedure for Youth Courts throughout the State of Mississippi, and Uniform Rules of Youth Court Practice were placed in effect on January 8, 2009.

Therefore, after having served the public for over 50 years, and being instrumental in the development of Youth Court procedures and legislation for Youth Court for the State of Mississippi, it is incumbent upon the Court to commend Judge Thomas B. As compensation for her services, Mrs. Williams shall receive the sum of \$15,000.00 per year for her services. Additionally, she shall receive the same group matching benefits afforded to the employees of Clay County, Mississippi.

IT IS FURTHER ORDERED AND ADJUDGED that, while serving as Special Master for civil commitments and as Youth Court Referee, Mr. Ross and Mrs. Williams shall take any and all steps necessary to hear and adjudge cases brought under Section 41-21-61, et seq., of the Mississippi Code of 1972, as amended and annotated, and under the applicable statutes for commitments of people alleged to be mentally ill, alcoholics and drug addicts, including but not
